RESOLUTION RE-APPOINTING MEMBERS TO THE CONCENTRATED ANIMAL FEEDING OPERATIONS PERMITTING STUDY COMMITTEE AND EXTENDING REPORTING DEADLINE

WHEREAS, The Town of Trade Lake (the "Town") adopted Resolution 20-04 on November 12, 2020 authorizing the creation of a concentrated animal feeding operations ("CAFO") study committee (the "CAFO Permitting Study Committee") to further evaluate and review the potential effects of CAFO's on the health, safety, and general welfare of the residents of the Town, including impacts on air quality, public infrastructure, property values, and the local economy; and

WHERAS, the Town adopted Resolution 2022-02 on January 13, 2022 re-appointing members to the CAFO Permitting Study Committee for so long as the Committee shall remain active and extending the reporting deadline, and the CAFO Permitting Study Group was to meet regularly and report to the full Town Board results of the findings no later than December 31, 2022 regarding the proposed revisions and supplementation to the Town's Concentrated Animal Feed Operations Ordinance; and

WHEREAS, it was resolved the CAFO Permitting Study Committee shall be composed of members of the community of the Town of Trade Lake, at least one Town Board member and experts from applicable disciplines and fields, including but not limited to geology, hydrogeology, soils, immunology, public health, engineering, law, real estate, environmental protection and air quality.

WHEREAS, the following individuals have served on the CAFO Permitting Study Committee:

NOW THEREFORE BE IT RESOLVED THAT, the above-referenced appointees be reappointed to the CAFO Permitting Study Committee for so long as the Committee shall remain active.

BE IT FURTHER RESOLVED THAT, the CAFO Permitting Study Committee shall meet regularly and report to the full Town Board the results of its findings no later than December 31, 2023 regarding proposed revisions and supplementation to the Town's Concentrated Animal Feeding Operations Ordinance.

The Town Clerk shall properly post or publish this resolution as required by law under Sec, 60.80 of Wis. Statutes. Resolution takes effect the day after posting.
