Public Comment: Ramona Moody stated the bids have increased for paving seal coting and gravel crushing from the county. Rick Painter acknowledged the Board for the work that they have done over the last year.

Highway Report: It was decided by publish the bid for paving Freedom Lake Rd. and open at the next monthly meeting Roads are posted for weight limits.

Fire Report: None for Frederic. None for Grantsburg.

Ambulance Report: Supervisor Hinrichs reported that he has heard nothing on combining meeting with Amery.

Water Study Committee Report: Rick Painter reported that the lake association did receive the grant for \$ 2500.00 and this will be used to reduce the cost of the well test kits for the residents. Currently there are about 150 requests for well tests.

Chairman CAFO Report: supervisor Hinrichs reported there has been no further development with Cumberland LLC in applying for permits per Jeff Jackson from the DNR.

CAFO Ordinance Committee Report: Supervisor Lade reported they are gathering information that is scientifically defensible to support the ordinance and developing an outline of wants and needs for the ordinance.
