Liquor License: Motion by Lesak to Approve Trade Lake Store Liquor License, seconded by Doornink. Motion carried by voice vote.

Land/Shed rent: After discussion, no was action taken

Gateway Bass Club-dock request for Spirit Lake: The Bass Club requested permission for them to install a dock on Spirit Lake. It was outlined to the Bass Club per previous direction from the Town's Attorney, they would need to have an agreement with the town for the Bass Club to install, inspect, maintain, and repair dock access as well as liability insurance to hold the town harmless. The Bass Club indicated they would only place the dock and donate it to the town. Motion by Moody to deny the request based on the information that was outlined by the town attorney and the lack of the Bass Club providing that. Seconded by Doornink. Motion carried by voice vote.

CAFO update: Tyler Dix with the DNR stated nothing new to report.

Town Website: Town Web is our current hosting company. They are making changes to their system and fees. There is a new 2-year contract. Changing hosting from Town Web to Gilhoi Web Design would save the town approximately \$800 per year in the future pending price changes. Motion by Moody to use Jay Gilhoi with Gilhoi Web Design for the Town website services. Seconded by Lesak. Motion carried by voice vote.

Burnett County District 5 Supervisor update: no update

Burnett County Comprehensive Plan update: Open house will be May 20th from 6-8p.m at government center with presentation at 6:30 on the draft plan and a public hearing on June 4th @ 9:00 am at government center.

Town of Trade Lake Comprehensive Plan committee update: committee met on April 22nd, in the process of researching what may or may not need to be added to the comprehensive plan for solar guideline. Next meeting is June 3 @ 6pm
