Motion by Moody to approve the amendment. Roll call vote to approve the amendment: Doornink: yea; Lesak: yea; Moody: yea. Motion carried.

Fire Reports: Marjean Legler gave Frederic Fire Report: They have had 39 calls. Hog roast is this Saturday (June 11th). Dean Gabrielson gave minutes of Grantsburg Fire's May meeting: 50 runs year to date. Pancake breakfast had a good attendance. Antenna on water tower needs to be replaced, quote is \$3,183.00

Northwestern EMS Bylaws and Ambulance contract (North Land Municipal & Amery Area Ambulance merger documents) Discussion & decision on Ambulance Service Provider: Town board will request North Memorial send a contract to the town's attorney for review. After the town's attorney has reviewed and gives recommendations, the town board will call a special meeting for decision on Northwestern EMS Bylaws and Ambulance contract and ambulance provider for 2023.

- e- Chip sealing projects: Jeremy will bring projects to the special meeting.
- f- Shop floor/apron repair: Review quotes and award project. Cornerstone Architectural Concrete & Masonry, Ilc patch broken slab 20'x22'x6" \$3,960 and 48'x48'x6" concrete floor for remainder of shop \$20,736.00 totaling \$24,696.00. Motion by Doornink to approve bid of \$24,696.00 for concrete and the apron as well. Seconded by Lesak. Motion carried by voice vote.
- g- Machinery needs/purchasing gravel reclaimer, update: 3-point side mower: Motion by Lesak to do a 3-point side mower at a max of \$4,900.00. Seconded by Doornink. Motion carried by voice vote
- h- Review cost for driveway permits due to culvert expenses: Motion by Moody to amend the Resolution of Fee Schedule for the Town of Trade Lake with the charge of the driveway permit to add actual cost of culvert. Seconded by Lesak. Motion carried by voice vote.
