



## Q2.2025 quarterly meeting of the Round Lake Management District Board of Commissioners

Affidavit of Posting: Notice was posted by 05.31.2025 by 9:30a.m. at the Trade Lake Store, Bass Lake Lumber, and Trade Lake Town Hall.

Approval of Agenda Order and Q1.2025 minutes: Motion by Greg to approve the agenda order and Q1.2025 meeting minutes. Seconded by Doug. Motion carried by voice vote.

Grant updates: Have all been posted to the lake Facebook page (after many rounds of invites and calls to join, we think we have a good portion of the property owners represented, but not all). Greg took out a business loan to purchase the weed harvester and created an LLC for it. Harvesting has begun, volunteers are asked to help educate the public at the boat launch on Saturdays and Sundays.

Treasurers report: We received a \$100 donation which was deposited into our account. Greg deposited \$100 to help as we were facing a deficit. Paper handouts of the budget summary were available at the meeting with a breakdown of deposits and debits. No questions on the current state of the budget.

Dock removal discussion: The dock at the public boat launch was removed by its owners – the Bass Association - recently as there was an issue with the dock not having insurance liability coverage and the town attorney advised that coverage be obtained or the dock to be removed. Round Lake was not the only lake affected by this; others had their docks removed as well. Insurance costs are high but the Association is still looking into options.

Round Lake Sportsman's Association update: This association was created directly to support stocking our lake and will help raise funds to pay for the fish. This is a 503c and can accept donations as well as employer matches. Annual meat raffle to raise funds will be at Classerts Resort on July 5<sup>th</sup>, flyers were distributed to the public.

Public Comments / Questions: Greg shared an update about the health of the fish in our lake. Some crappies are sick with sarcoma and there is a fungus growing on some sunfish, estimating about 70% of these fish are affected but to not get overly concerned until we see 100s of them dead. The direction is to humanely and safely remove and dispose of these fish if caught, somewhere not close to the lake as the sickness is spread by contact. DNR does not have funding to study the sarcoma but noted that it is only happening locally in a few lakes at this time. No other public comments.

Agenda for Annual meeting to be forthcoming and is scheduled for August 23<sup>rd</sup> at Classerts Resort.
