**Fire Reports:** Frederic fire next meeting 4/13/2026. Grantsburg Fire continuing to review bylaws, incidences 40 as of this time last year, as of year to date this year its 22, Fire inspection service company started doing inspections on March 17<sup>th</sup>. Todd reported 20 personal is with one joining, 2 are doing training, Rush city has reached out to Todd would like to start conversation on mutual aid. Todd is going to meet with their chief, gather information and report back to the association.

**Highway Maintenance Report:**

- a. **Emergency Petition for County-cost share**, culvert on Spook Road, Highway commissioner said it is a 36-inch culvert and falls in the approved criteria for requesting the cost share. The County Infrastructure Committee reviewed the town's draft letter and approved the cost share for Spook Road culvert replacement, total cost is \$6,355.79, Trade Lake would be responsible for half of this expense. Scott recused himself from the vote. Motion by Moody to approve emergency petition, to the county for Spook Road culvert cost share replacement, with a total cost of \$6,355.79. 2<sup>nd</sup> by Lesak. Motion carried by voice vote.
- b. **County Contract Too Spray Wild Parsnip & invasive Weed Species:** Scott recused himself from the vote. Motion by Moody to contract with the County for spraying the road-right-of way for up to \$3,200. 2<sup>nd</sup> by Lesak. Motion carried by voice vote.
- c. **Spring Road Review:** Jeremy will put a list together of roads that need some repair and get a list to Marjie.
- d. **Additional Cameras for gate and yard area**, tabled until a later meeting
